

# Elevation Gold Mining Corp. Announces Interest Payment on Convertible Debentures

[Elevation Gold Mining Corp.](#) (TSXV: ELVT) (OTCQB: EVGDF) (the "Company" or "Elevation Gold") announces that under the terms of the convertible debentures issued under the convertible debenture indenture dated July 31, 2020 (the "Indenture") between the Company and Computershare Trust Company of Canada, it has elected to satisfy its obligation to pay an aggregate of C\$167,290 in interest accrued on the C\$6.71 million convertible debentures by issuing to such debenture holders on the interest payment date of June 30, 2024 an aggregate of 1,968,122 common shares.

The Company will pay to each such debenture holder approximately 29.33 common shares per \$100 principal amount of debentures held as at the applicable interest payment record date. Under the terms of the Indenture, no fractional common shares will be delivered upon payment of the interest obligation and the Company is not required to pay the cash equivalent of any amount less than \$5.00. The issuance of common shares in payment of interest remains subject to Exchange approval.
