

Vizsla Royalties to Commence Trading on TSX Venture on August 26, 2024

Vancouver, August 22, 2024 - [Vizsla Royalties Corp.](#) ("Vizsla Royalties" or the "Company") is pleased to announce that its common shares (the "Shares") and warrants have been conditionally accepted for listing on the TSX Venture Exchange (the "Exchange") as a Tier 2 issuer under the symbol "VROY" and are expected to commence trading at the opening of the market on August 26, 2024.

On August 6, 2024, the Company completed a consolidation of the Shares on the basis of one new Share for every existing ten Common Shares (the "Consolidation").

On July 30, 2024, the Company closed a non-brokered private placement (the "Private Placement") of Shares for gross proceeds of \$5,192,498. 8,654,164 Shares (on a post-Consolidation basis) were issued at a price of \$0.60 per Share (on a post-Consolidation basis) pursuant to the Private Placement. 829,999 of these Shares were subscribed for by insiders of the Company.

Securityholders are not required to exchange their securities certificates or take any other action in connection with the listing, as there will be no change to the CUSIP for the Company's securities.

The Company's principal asset is a Net Smelter Royalty on [Vizsla Silver Corp.](#)'s (TSXV: VZLA) (NYSE: VZLA) flagship Panuco Project located in Mexico. Panuco is a world-class silver and gold development project actively advancing towards production. Panuco currently hosts an estimated in-situ indicated mineral resource of 155.8 Moz AgEq and an in-situ inferred resource of 169.6 Moz AgEq (please refer to Vizsla Silver's Technical Report on Updated Mineral Resource Estimate for the Panuco Ag-Au-Pb-Zn Project, Sinaloa State, Mexico, by Allan Armitage, Ben Eggers and Peter Mehrfert, dated February 12, 2024).
