

Leopard Lake Gold Corp. Completes A Shares For Debt Transaction

Toronto, Sept. 18, 2024 - [Leopard Lake Gold Corporation](#) (the "Company" or "Leopard Lake") (CSE: LP) wishes to announce the completion of a shares for debt transaction. On September 17, 2024 the Company issued 1,922,711 common shares at a price of \$0.045 per share for a total consideration of \$86,522.10 of which three vendors received 698,401 common shares against \$31,428.10 of debt and three insiders received 1,224,310 common shares against \$55,094.00 of debt.

The three insiders included the CEO for \$25,000. of debt, a director for \$2,500. of debt, and a company managed by the Chairman for \$27,594. of debt.

The shares have a restricted legend date of January 18, 2025.

There are now 44,544,269 common shares issued and outstanding.

Leopard Lake is engaged in the business of mineral exploration and the acquisition of mineral property assets in Canada, including the St. Robert property, which is comprised of 4 mining claims in Beauceville and 102 mining claims in the Riseborough and Marlow Townships in St. Robert Bellarmin, Quebec, and the Stella property located in the Abitibi region of Northwestern Quebec, made up of 52 contiguous mining claims for a total of 2,987 hectares, approximately 65 kilometres east of the town of Val d'Or. The objective is to locate and develop economic precious and base metal properties of merit and to conduct exploration programs.
