

Vittorio Valsecchi Acquires Securities In Prospera Energy Inc.

CALGARY, Jan. 9, 2025 - On January 7, 2025, Vittorio Valsecchi, through Valsecchi Immobilien AG, a company under Mr. Valsecchi's control and direction, acquired 1,200,000 common shares ("Common Shares") of [Prospera Energy Inc.](#) (TSXV: PEI); (OTC: GXRFF); (FRA: OF6B) (the "Company") at a price of approximately C\$0.035 per Common Share for an aggregate purchase price of C\$42,489.42 (the "Acquisition"). The purchased Common Shares were acquired through the facilities of the TSX Venture Exchange.

Prior to the Acquisition, Mr. Valsecchi beneficially owned an aggregate of 53,550,000 Common Shares of the Company, representing approximately 12.54% of the issued and outstanding Common Shares on a non-diluted basis. Prior to the Acquisition, Valsecchi Immobilien AG owned an aggregate of 6,000,000 Common Shares of the Company, representing approximately 1.40% of the issued and outstanding Common Shares on a non-diluted basis. As a result of the Acquisition, Mr. Valsecchi now directly or indirectly, beneficially owns 60,750,000 Common Shares, representing approximately 14.22% of the issued and outstanding Common Shares of the Company on a non-diluted basis. As a result of the Acquisition and since the date of his previous Early Warning Report of July 17, 2024, Mr. Valsecchi has increased his total shareholdings by an amount equal to 2.15% of the issued and outstanding Common Shares of the Company.

Mr. Valsecchi acquired the Common Shares for investment purposes. Mr. Valsecchi may acquire additional securities of the Company in the future, may dispose of some or all of the securities or may continue to hold his current position.
