

# Aris Mining Completes Sale Of Juby Gold Project

[Aris Mining Corp.](#) (Aris Mining or the Company) (TSX: ARIS) (NYSE-A: ARMN) announces that it has completed the previously disclosed sale of its Juby Gold Project and related interests in Ontario, Canada, to [McFarlane Lake Mining Ltd.](#) (McFarlane) for a total consideration of US\$22 million, receiving US\$13.2 million in cash and 82,023,746 common shares of McFarlane (representing 19.9% of McFarlane's post-financing share capital on a non-diluted basis, issued at C\$0.15 per share).

This sale transaction aligns with Aris Mining's strategy to focus on its high-growth gold operations and development projects in Colombia and Guyana.

## About Aris Mining

Founded in September 2022, Aris Mining was established with a vision to build a leading Latin America-focused gold mining company. Our strategy blends current production and cashflow generation with transformational growth driven by expansion of our operating assets, exploration and development projects. Aris Mining intends to unlock value through scale and diversification. The Company is listed on the TSX (ARIS) and the NYSE-A (ARMN) and is led by an experienced team with a track record of creation, operational excellence, financial discipline and good corporate governance in the gold mining industry.

Aris Mining operates two underground gold mines in Colombia: the Segovia Operations and the Marmato Complex, which produced 210,955 ounces of gold in 2024. With expansions underway, Aris Mining is targeting an annual production rate of more than 500,000 ounces of gold, following the commissioning of the second mill at Segovia, completed in June and ramping up production in H2 2025, and the construction of the Bulk Mining Zone at the Marmato Complex, expected to start ramping up production in 2026. In addition, Aris Mining operates the 51% owned Soto Norte joint venture, where a PFS study is complete on a near-term scale development plan which confirms Soto Norte as a high-quality, long-life project with robust economics and industry-leading environmental and social design features. In Guyana, Aris Mining owns the Toroparu gold/copper project, where a new Environmental Impact Assessment (PEA) is underway.

Colombia is rich in high-grade gold deposits and Aris Mining is actively pursuing partnerships with the Country's dynamic small-scale mining sector. With these partnerships, we enable safe, legal, and environmentally responsible operations that benefit both local communities and the industry.
