

# Hannan Announces Upsize of Non-Brokered LIFE Offering of Common Shares

Vancouver, November 18, 2025 - [Hannan Metals Ltd.](#) (TSXV: HAN) (OTC Pink: HANNF) ("Hannan" or the "Company") announces that, as a result of strong investor demand, the Company has increased the size of its previously announced non-brokered private placement offering under the Listed Issuer Financing Exemption (the "Offering") to up to 14,000,000 common shares (the "Common Shares") at a price of \$0.75 per Common Share (the "Offering Price") for gross proceeds of C\$10,500,000. The Offering continues to be subject to a minimum of C\$4,000,000.

The Company intends to use the net proceeds of the Offering to fund exploration expenditures at the Company's projects in Peru, including to continue to advance the drill program at the Company's Belen prospect, and for general corporate and administration costs and general working capital.

The Offering is expected to close in tranches by November 28, 2025, and is subject to the Company receiving the necessary regulatory approvals, including the conditional approval from the TSX Venture Exchange ("TSXV"). The Company may pay finder's fees in cash to certain arm's length finders engaged in connection with the Offering, subject to the approval of the TSXV.

Subject to compliance with applicable regulatory requirements, the Offering is being conducted pursuant to the listed issuer financing exemption under Part 5A of National Instrument 45-106 - Prospectus Exemptions and in reliance on the Coordinated Blanket Order 45-935 - Exemptions from Certain Conditions of the Listed Issuer Financing Exemption (the "Listed Issuer Financing Exemption"). The securities issued to purchasers in the Offering will not be subject to a hold period under applicable Canadian securities laws.
