

# Heritage Mining Announces Non-Brokered Private Placement of Units and Flow-Through Units

[Heritage Mining Ltd.](#) (CSE:HML) (FRA:Y66) ("Heritage" or the "Company") is pleased to announce a non-brokered private placement (the "Offering") of units ("Units") and flow-through units ("FT Units") for gross proceeds of up to \$810,000.

Pursuant to the Offering, the Company intends to issue up to 10,000,000 Units of the Company at a price of \$0.025 per Unit, for aggregate gross proceeds of up to \$250,000, and up to 20,000,000 FT Units of the Company at a price of \$0.028 per FT Unit, for aggregate gross proceeds of up to \$560,000.

Each Unit will consist of one common share in the capital of the Company ("Common Share") and one Common Share purchase warrant (a "Warrant"). Each FT Unit will consist of one Common Share which will qualify as a "flow-through share" as defined in subsection 66(15) of the Income Tax Act (Canada) and one Warrant.

The gross proceeds from the FT Units will be used by the Company to incur eligible "Canadian exploration expenses" that qualify as "flow-through mining expenditures" as both terms are defined in the Income Tax Act (Canada). The Company also intends that such expenses incurred will be eligible for the Critical Mineral Exploration Tax Credit.

Each Warrant will entitle the holder to acquire one Common Share (each, a "Warrant Share") at an exercise price of \$0.05 per Warrant Share until 4:30 pm (Pacific Standard time) on that date that is 60 months from the closing date of the Offering (the "Expiry Time").

Closing of the Offering is expected to occur on or around November 28, 2025 (the "Closing Date"). The Offering is subject to all customary approvals. Proceeds of the Offering will be used to fund the Company's planned exploration and drilling programs on its Drayton-Black Lake Project and Contact Bay and general working capital. The securities issued pursuant to the Offering will be subject to a four month hold period under applicable securities laws. In connection with the Offering, certain finders may receive a cash fee and/or nontransferable finder warrants.

A Finder's Fee equal to 7% cash and compensation unit warrants ("Compensation Unit Warrants") equal to 7% of the gross proceeds of the sale of Units and FT Shares, as applicable, issued pursuant to the Offering may be payable on certain orders in accordance with CSE rules. Each Compensation Unit Warrant will entitle the holder to acquire one Common Share and one Warrant of the Company at an exercise price of \$0.05, for a period of 60 months following the Closing Date.

A Finder's Fee equal to 1.0% cash compensation on the number of Units or FT Shares, as applicable, issued pursuant to a President's list the Offering may be payable on certain orders in accordance with CSE rules.

"Heritage Mining Ltd. has secured lead orders totaling up to C\$550,000 from insiders, institutions, advisors, consultants, and existing shareholders.
