## Gold Reserve Provides Update on Citgo Sale Process: Delaware District Court Enters Final Sale Order for Sale to Elliott/Amber

Gold Reserve Ltd. (TSX.V: GRZ) (BSX: GRZ.BH) (OTCQX: GDRZF) ("Gold Reserve" or the "Company") announces that the U.S. District Court for the District of Delaware (the "Delaware court") issued the final order authorizing the sale of the PDVH Shares to Elliott/Amber Energy. The Delaware court has also ordered that the closing of the sale is stayed until, at the earliest, seven days after the Special Master files a notice indicating that Elliott/Amber Energy has obtained all OFAC and other regulatory and necessary approvals and that the sale is ready to close.
