## Pure Energy Announces AGM Results and Appointment of New Director

Vancouver, December 19, 2025 - <u>Pure Energy Minerals Ltd.</u> (TSXV: PE) (OTCQB: PEMIF) ("Pure Energy" or "the Company") announces the voting results from its Annual General Meeting of Shareholders (the "Meeting"), held on December 19, 2025, including the appointment of William Morton to the Board of Directors of the Company.

- Setting the number of directors at five, with the following five nominees elected as directors: Marceau Schlumberger, Daniel Barnosky, Yuwei Hong, Cameron Hosie and William Morton; and
- Approving the Company's new Long-Term Incentive Plan.
