

# Highland Critical Minerals Corp. Announces Summer Exploration Program

Toronto, May 5, 2026 - [Highland Critical Minerals Corp.](#) (CSE: HLND ) (FSE: U8X0) ("Highland Critical" or the "Company") is pleased to announce its plans for its summer exploration program for its Church Property located in Northern Ontario.

Following the completion of its non-brokered flow-through private placement for gross proceeds of \$400,000, the Company expects to begin its summer exploration program at the end of May 2026. The intended program is expected to include completion of a radiometric and LIDAR geophysical survey and a sampling program. The program will be subject to weather conditions, and it is expected that the exploration expenditures will qualify as eligible expenditures for the use of the flow-through funds.

Ted Yew, Chief Executive Officer of the Company, commented, "We are excited to have support from the market, which resulted in the successful closing of our flow through financing and are looking forward to providing an update on exploration program at the Church Property in the coming months."
